Colleton County Council met on Friday, May 10, 2019 at 12:30 PM, at the County Dogwood Hills Golf Course, 1 Dogwood Lane, Walterboro. Dr. Flowers called the meeting to order with Council Members Gene Whetsell, Steven Murdaugh, Art Williams and Phillip Taylor in attendance.
