MINUTES TUESDAY, OCTOBER 5, 2021 VIRTUAL REGULAR MEETING 6:00 P.M.

Colleton County Council Council Chambers, Old Jail Building 109 Benson Street Walterboro, SC 29488

Present: Chairman Steven Murdaugh called the meeting to order with Council Members Dr. Joseph Flowers, Art Williams, Gene Whetsell, and Phillip Taylor in attendance.

Others Included: Kevin Griffin, Sean Thornton, Meagan Utsey, Jon Carpenter, Kaela Brinson and Barry McRoy.

Phillip Taylor gave the invocation and led the Pledge of Allegiance.

Approval of Minutes

A. **Regular Meeting Minutes, September 7, 2021** — Councilman Phillip Taylor moved to approve the minutes of the Regular Meeting held on September 7, 2021. The motion was seconded by Councilman Art Williams and the motion carried unanimously.

Awards and Recognitions

A. Proclamation for Colleton County Council's Recognition of Patricia C. Grant and her Service to Colleton County— Chairman Murdaugh read the Proclamation aloud. Dr. Joseph Flowers moved to approve the motion, and it was seconded by Councilman Phillip Taylor. The motion carried unanimously.

Appearances and Public Presentations

- A. Michelle Gaston, Chapter Chair Service Corps of Retired Executives: She and Michael Waters, Vice Chair, gave an overview presentation on SCORE SC Lowcountry.
- B. Charles Bright Ritter Community Revitalization Project: Mr. Bright discussed the idea of a revitalization project for the Ritter area and the benefits it might give to the community.

No discussion or questions.

Administrator's Briefing

Mr. Kevin Griffin stated that we have recently reenacted the Colleton County Accommodations Tax Advisory Board. In previous years we have not collected enough accommodations tax to be available for grants added to the community from the Accommodations Tax Advisory Board. In more recent years we have been able to collect in excess of \$25,000. That excess goes into a fund to be allocated back through the Accommodations Tax Advisory Board and then through council. The board has seven seats in total, four from lodging and hospitality, one from cultural arts, and two at large. We have \$60,000 that needs to be allocated, of that \$20,000 needs to be allocated by June 30, 2022, and the \$40,000 needs to be allocated by June 30, 2023. We need to encourage people from these industries to participate so we can keep this money in Colleton and not have to give it back to the state.

Councilman Taylor: I spoke with several people in hospitality and lodging, more specifically from hotels in the area, most of the ones you would seek to serve on our board are also serving on the city accommodation tax board. Would this be a conflict for an individual to do both?

Sean Thornton: I will do some research on this, however, there are some city positions that have been held to be offices for dual office holding. I don't know that one being city and one not being city would be dispositive of the issue, but I will be happy to research that for y'all.

Councilman Williams: Are these the same individuals, or do we need new members for the Colleton County Accommodations Tax Advisory Board?

Mr. Griffin: We do need all new individuals.

Councilman Taylor: Stated that we do have one member on the board so far.

No further discussion.

Kimberly Mullinax, Lowcountry Council of Governments: Floyd Buckner building demolition which was awarded in September of 2020. This is a result of the tornado we had in April 2020. It took the roof off the building and deemed it structurally unsound. The building was located at the corner of Jefferies Blvd and W. Washington St. in downtown Walterboro. It was actually a three story building with much of it underground. It was backfilled with dirt and grass was planted. This project was eligible due to the spot slum/blight national objective and benefited approximately 5,165 residents of which 2,530 (@49%) were considered low-to-moderate income persons. The

grant was awarded for \$363,000. We have completed all the work and have spent \$196,000 and will be returning \$166,000 to the state that was unused. We had to commit the 10% match which was \$76,498.00. This project it set to be monitored financially and programmatically in October and hope to have it closed out by the end of October. Ms. Mullinax asked for any questions or comments.

No comments were made/received.

East Side Water Upgrade which was done in conjunction with the City of Walterboro. Awarded in June 2019. This project was done to improve the water pressure and fire flow on Francis Street, Barracada Road, Live Oak Street, 6th Street, and Hickory Street. This project served 135 residents at 81% LMI. This grant was awarded for \$487,500 we are still trying to total the last invoices on this but are looking to return about \$60,000 under budget. The local match on this was \$61,323 which is covered by the city of Walterboro since they will be the ones to own and maintain the water system. This project it set to be monitored financially and programmatically in October and set to have it closed out by the end of December.

No comments were made/received.

Public Comments

Carol Black: I believe the county should publicly recognize Barry McRoy for his efforts during the COVID-19 pandemic. He and his department are already handling the emergencies that arise in "normal" times--but on top of that they have to assist those who have developed the COVID virus--whether the person has been vaccinated or not. Barry has recently come under criticism from a Colleton County resident (in two "letters to the editor" in the local newspaper)--and I think it is important for ALL citizens of the county to see that the council members support Barry and value his dedication to his truly "life-saving" work. I see that council recently issued a proclamation honoring the late Magistrate Richard Wood--and I think Barry deserves the same type of commendation--which I hope will be covered in the same local newspaper. Thank you.

Council Time

Councilman Taylor: We would like to make the public aware that we received as a County "Code Red" being implemented by Colleton County's Fire-Rescue Emergency Management Division. This is an opportunity available to every resident in Colleton County. They can get alerts sent to their home phones via a voice message, by a mobile phone via text message, or by an email address. The Code Red notifications are an alternative to social media, which I think came at a great time as we recently saw a huge outage on social media networks just yesterday. Code Red will also interface with the Integrated Public Alerting & Warning System (IPAWS). More information can be found about operation Code Red by visiting colletonfire.com/codered or by

texting "alertcolleton" to 99411. For example, with the wash out on Hendersonville Highway, code red would send out an alert during incidents like these, so that residents can take an alternate route. All Colleton County residents should register with this free alerting system as it will be very beneficial.

Also, at the Lowcountry Council of Government there is a Lowcountry Rural Transportation survey for anyone who is concerned with transportation and/or roads issues. This can be found by going online to lowcountrycog.org. Look for LATS and Rural Area 2045 Long Range Transportation Plan Survey. We need as many residents who would like to have input on this survey to read the information, make their concerns aware by completing the survey, or you can also call (843) 473-3990 to find out more about this survey.

Also, I just wanted to mention there is a concerted effort by the COG to take an extensive look at the senior and aging population, what we are doing right and what are we not doing right. Ms. Barbara Johnson is heading that up. I would like anyone who have some ideas on how we can better serve seniors in our community to please contact Lowcountry COG.

Also, tonight when we made the presentation to Ms. Grant, Senator Bright mentioned that maybe there could be a way that our county could have a recognition similar to what the state does with the Order of the Palmetto, other counties appear to be doing so. Maybe we have citizens that we would like to recognize beyond a normal proclamation; a citizen's award.

Art Williams: Lowcountry Community Action does have some funding to support those that are behind on their rent.

COUNCIL-ADMINISTRATOR FORM OF GOVERNMENT FOR COLLETON COUNTY

[To Ratify FY21 Grant And Budget Resolutions And Related Appropriations For All Funds; To Ratify Transfer And Other Resolutions Previously Authorized By Council; And Other Matters Related Thereto.]

WHEREAS:

- 1. Colleton County Budget Ordinance requires supplemental appropriations for unanticipated revenues received after the adoption of the budget; and
- 2. The County regularly adopts a final budget amendment ordinance to account for budget resolutions and interfund transfers authorized by Council during the fiscal year, as well as grants and any other supplemental appropriation actions in accordance with the 1976 South Carolina Code of Laws, as amended, and the County's budget ordinance.

NOW THEREFORE BE IT RESOLVED BY THE COLLETON COUNTY COUNCIL DULY ASSEMBLED THAT:

- 1. The Colleton County Council hereby:
 - a. Ratifies all previously approved FY21 Budget Resolutions and authorizes and directs the County Administrator to amend the FY21 budgetary appropriations as so resolved;
 - b. Ratifies all previously approved FY21 Resolutions related to amendments to the County Record of Roads (ROR), if any.
 - c. Ratifies all Resolutions, voice motions, and other actions approved by County Council for Fiscal Year ending 6/30/21 including those awarding contracts, directing specific fiscal actions such as authorizing, increasing or reducing fund transfers, operational transfers, reclassifications, fund balance designations, and fund balance appropriations.
 - d. Approves the budgeting of funds, if any, received by the CCRFC from Covenant Billing during the Fiscal year ending 6/30/21, within Fund 156 to meet the needs of the County.
 - e. Approves acceptance of FEMA and SC Emergency Management Division disaster assistance funds in the amount of \$119,528 to cover final debris management costs associated with April 2020 Tornadoes.

- f. Approves acceptance of South Carolina CARES assistance funds in the amount of \$253,901 to cover costs incurred across all funds associated with COVID-19.
