Appearances & Public Presentations

DJJ Annual Report – Ms. Torsha Anderson gave an overview of all of their activities for 2020.

Administrator's Briefing

Mr. Griffin – Old Business item "b" Mr. Clyde Creel has stopped by twice in the last two weeks and just wanted to extend his thanks to Council for assisting him to get this property back in his family name. As you know it was given to the water company and eventually came over to the Fire-Rescue for a temporary fire station and now he has gotten it back. We have worked through that and will have 3rd reading in June.

Item "a" New Business, the county owns a lot on the corner of North Lemacks Street. Palmetto Rural is putting in fiber all the way down that road, so they are just asking for an easement (5 Ft.) in order to install that fiber.

One other item that will be at the end of the agenda with the appointments of council vacancies. We will have something new there. This year is the first time in I believe in thirteen years since the City annexed both interchanges that we will have over \$50,000 collected in Accommodation Tax for the Special Revenue Fund. By State law once that is done you have to re-form your Accommodations Tax Board, which is a seven member board. Four of them come from Lodging and Hospitality, one from Cultural Arts, and the other two are at-large, so we will be advertising for those and also will let the Hospitality Industry Board know so that it is ...inaudible... right now they will have roughly \$35,000 to portion out once they are put together and reconstituted there. We anticipate that to grow because actually this year we hit the \$50,000 in the third quarter. We have been getting it in the fourth quarter, but that ended the year, so we haven't had to form that board yet. Therefore they'll have a little something to work with when they are put together.

A motion to approve 2nd reading was made by Mr. Whetsell and was seconded by Mr. Taylor.
