**Article 6, Item 6.01**

Questions will be received in writing until 5:00 PM on July 5<sup>th</sup>.

**Clarification:**

Questions directly from suppliers will not be answered. They must be submitted from the prospective bidders.

**Question and Answers:**

**Question:** Can the utility lines on the airfield site be marked?  
**Answer:** Yes. The County will have the lines marked by utility companies prior to bid being received. These marking shall be used for bidding purposes only. The contractor is responsible with having the lines remarked before starting construction. Colleton County assumes no responsibility for the accuracy of the markings. ***The Owner contacted 811 on 6-27-17. All lines should be marked by 7-3-17.***

Question: There appears to be different units for the quantities of pavement repair. Can this be made consistent?  
Answer: AECOM will look at developing a consistent measurement for all pavement repair on the bid form. The updated bid form will be issued in an addendum on 7-7-17

Question: Is there any soil contamination at the airport?  
Answer: There is no known soil contamination at the airport.

Question: Will there be a charge for a water business license?  
Answer: No.

Question: Will the contractor be allowed to store materials and equipment on the site?  
Answer: Yes. The County will coordinate with the airport operator and the contractor on an area to store materials and equipment.

Question: When is the anticipated construction start date?  
Answer: Construction is anticipated to begin 10 days after County Council's approval (anticipated start date; August 4, 2017).

Question: Is there a Local Preference goal?  
Answer: No.

Question: Are there any restrictions on when work can be done?  
Answer: No.

Question: Can the Notice to Proceed be held during the shop drawing submittal process?  
Answer: No.

Question: What is the project schedule?  
Answer: The project must be completed in 180 days from the Notice to Proceed.

Question: Is there a Buy America requirement?  
Answer: Yes. Please refer to the project specifications.

Question: Is there grant funding involved?  
Answer: Yes. There is grant funding from both the federal and state level.

Question: Is there an MBE requirement?  
Answer: No, but it is encouraged.

Question: Is certified payroll required?  
Answer: No. Payroll will be certified by the coordinator.

Question: Can plans be made available electronically?  
Answer: PDF plans will be made available only to official plan holders via AECOM's secure FTP site.
