ADDENDUM 1 Date: November 2, 2022

The following questions have been submitted for clarification:

- 1) Can the contract time be extended? Answer: Yes, the contract completion date is hereby changed to 360 days from NTP.
- 2) For the GABC, will FLBC (limestone base) be acceptable? Answer: No, granite base (MBC) or crushed concrete will be the only acceptable GABCs. Note: Crushed concrete must be used on the entire length of the roadway. Granite base and concrete base cannot be mixed.
- 3) Is there a pre-bid meeting for this project? Answer: NO
- 4) Will testing be required? Answer: NO
- 5) Some of the roads are wider than the stone that will be placed. Who will determine where the stone is placed? Answer: The County Engineer will determine the stone location, but in most all circumstances the existing centerlines of the roadways will remain.
- 6) See attached updated BID FORM with Alternates. The bid will be award on the contractor's base bid. The alternates may be awarded to the low bid contractor at the time of award or received as information only for award at a later date.
