2. County Council authorizes the County Administrator to expend Eight Thousand Six Hundred Twenty-Six Dollars and Twenty Cents (\$8,626.20) for the Sheriff's Office Dispatch Battery backup and
3. County Council authorizes the County Administrator to expend One Thousand Four Hundred Thirty Dollars (\$1,430.00) for CPR Training.
