MINUTES TUESDAY, MARCH 5, 2024 REGULAR MEETING 6:00 P.M.

Present: Chairman Phillip M. Taylor, Sr. called the meeting to order with Council Members Dr. Joseph Flowers, Bubba Trippe, and Scott Biering in attendance. Chairman Steven D. Murdaugh was not in attendance.

Councilman Bubba Trippe gave the invocation and led the Pledge of Allegiance.

Approval of Minutes

A. Regular Meeting February 6, 2024— Dr. Flowers moved to approve the minutes of the Regular Meeting held on February 6, 2024. The motion was seconded by Councilman Trippe and the motion carried unanimously.

Appearances and Public Presentations

A. Lowcountry Community Action Agency Annual Report– Tara Glover

***See attached presentation given by Tara Glover.

Councilman Trippe: Stated, thank you for all that you do, you do a great job. Is Safe Haven a shelter for only women and children?

Mrs. Glover: Stated, the shelter is for women, children, and families. We do have men that come through and we provide them with a meal and clothing. If they need to go into a hotel, we will provide that for them.

Councilman Trippe: Asked, how long can they stay?

Mrs. Glover: Stated, the max they can stay is 60 days. However, we know that it is hard to find affordable housing. We find that it is hard to place them in housing, because a lot of them have

evictions on their credit. So, we try to work with them and see if some of the landlords will work with us to try to get them into affordable housing. Otherwise, we allow them to stay until we are able to find suitable and affordable housing. We do not want to send them back out there and they become homeless again.

Vice Chairman Taylor: Stated, thank you Mrs. Glover.

Administrator's Briefing

Mr. Griffin: Stated, I wanted to take a moment to remember Mr. Homer. When I first moved here, he was one of the first people to welcome me to the community. He was a wonderful man with a heart of gold, and we will all really miss him. They had a great memorial for him yesterday.

On the agenda we have several items to discuss. Recreation, Item "A", we have a grant that has come through from the Delegation office for a miracle field (Thank you Mrs. Sue). This was primarily led by Senator Margie Bright Matthews. However, as we were working on this, we determined that we did not own the property. Somehow in 2009 when all the recreation property was transferred, this piece did not. So, we are correcting that.

We have a "by title only" on the general obligation bond. That would be to cover the Voter Registration Office, Coroner's Office, and cleaning up a few other projects that we are working on now, as well as purchasing those properties.

Item "N", wastewater improvements, that is part of the mega site wastewater project. We have a roughly 10 million dollar grant to run wastewater in conjunction with the city to run wastewater out to exit 57, gravity sewer, then on to the mega site property on Bells Hwy. They are putting a quick trip facility in, and it will cost us about a third of the price to go ahead and put the pipe in, rather than tearing out their infrastructure to put it in later. We worked with Coastal Electric on some RDA funds that they gave to the county. We ended up getting a pretty good price. It is an emergency procurement, right at \$200,000, to put both the sewer and water pipe in prior to them laying down any pavement. We are going to go ahead with doing that now. They can cap each end and connect to it once we get out there.

There are a couple of items with Capital Projects:

Green Pond Fire Station: This has an architect in place, and had the project kick off meeting on February 28th.

Freedom Field (Miracle League): I spoke about it previously being in design. We had to just get the land issue taken care of.

ADA Entrance (Harrelson Building): This is about 90% complete. Along with completing the 3rd floor office and moving ROD to the second floor to expand IT and GIS. If you drive by the Harrelson Building you will see the new generators and such going up. This is to keep our IT systems up and running.

Green Pond Community Center: This is about 80% completed.

RMP Building (Summer Feeding): This is almost complete. We are waiting on a punch list from the contractor.

Voter Registration: The electrical rough in is about 90% done, and the building is expected to be completed by July 2024 and be moved in by the General Election working directly.

Courthouse Window Replacement: There is a contractor contract in place. We are working on scheduling a kick-off meeting with a notice to proceed here shortly.

Venture Park (Working on the Spec Buildings): Wayne Brothers Construction is very interested in working in a Public/Private partnership with the county out there on additional properties. We are in discussion to do that.

Mega Site (Wastewater/Wastewater Infrastructure): We are working with both Michelle Knight and the EDA. We found out about another grant process on Friday that may allow us to go ahead and install the primary road from Bells Hwy to Ruffin. This grant is only available to rural counties with populations less than \$100,000 with minimum project size of 25 million.

Animal Control (CPST Project): A contractor has been selected and a contract should be in place by March 15th.

Emergency Operations Center (CPST Project): We have already had the kickoff meeting, and they should be in full design in the next month or so.

Johnsville Community Center (CPST Project): We are in a holding pattern here deciding if we want to move forward with the current funding or wait to hear back from our Legislative Delegation to know if there will be additional funding, which they requested to enlarge the facility. Recreational Pool and Gym Project (CPST Project): We have located a site here in downtown Walterboro. This will include a pool and small gym.

Veterans Park (CPST Project): We have Mr. Wallace Milling finishing up the Council Park, and we plan to put together a meeting by the 15th of this month to go ahead and get that moving forward. My understanding, the Veterans Park has been moved over to the airport property possibly.

Cottageville Library: We are waiting for the earmarked request from Representative Robby Robbins. He feels good about the request, and I believe we have the rest of the Delegation behind us on this.

Coroner's Facility (CPST Project): We have the architects in place.

We also have put in a PAR Grant for the pickleball courts out at the recreation center. This has become a very popular sport. Mrs. Ann Carmichael is behind that 100%. We have an idea of three, possibly four pickleball courts out at the recreation center.

Vice Chairman Taylor: Stated, Dr. Flowers asked if there were any items that were canceled for executive session.

Mr. Griffin: Stated, I have a written Economic Development update for you. Our director is meeting with a consultant and possible client tonight.

Vice Chairman Taylor: Stated, Thank you, Mr. Griffin.

Public Comments

Mrs. Felicia Johnson: Stated, I understand the lights will take a while over there but thank goodness we got a camera put over there and the club closed. I thought they were going to open, but you all shut it down. However, these ditches, everything stops at my residence on the corner

of Rivers and Madison Street. The trash is ridiculous, and I cannot get out in that ditch because it is still full. It is calling for a 90% chance of rain tomorrow, and I am praying my home, and my neighbors' homes don't get flooded out. My home insurance does not provide flood insurance. I fear for my grandson because he almost went into that ditch with his bicycle. Like I said, my exhusband did go into that ditch three times around Christmas and I told him I cannot help you. Last December, I was lying in my bed when I heard a noise, and a young lady went down into that ditch. Thank goodness there was no water in the ditch and my son, and her friend helped her get out. We truly don't need to dig this ditch any deeper. The ditch is almost as tall as I am. They need to cut open Rivers Street. The man that did the work on the ditch years ago told me they did not cross the water over Rivers. All they did was dig the ditches deeper and into the woods. We have got to tear up the street for water to flow and it is not flowing anywhere. Some peoples' ditch drains you can't even see because they are covered in dirt, but they keep digging ours deeper. You can ride Robertson Blvd and see what I am talking about. Like I said, we need help and I have grandchildren. I know that it is going to take some time on the lights, but I am going to keep pressing Dominion to go up Rivers Street. It is getting warmer, and I will be riding bicycles, and that is a drug zone. We need help with these ditches and lights, thank you very much.

Vice Chairman Taylor: Stated, thank you Mrs. Johnson.

Mrs. Sharon Witkin: Stated, good evening, Councilmen, staff, and Colleton County Residents. I am Sharon Witkin, Colleton County School District Board Member, and current chairman. I represent District 3 of Walterboro residence and have served as a school board trustee since 2018. I am grateful to stand before you in appreciation of the partnership we have with Colleton County to educate the youth in our community. I am also grateful that within this past week, Councilmen, I have shared conversation individually with all of you and spent time with you celebrating our community. The dashboard highlights the numbers and data we, as elected officials, strive to know and understand as we work towards the betterment of our community.

Colleton County School District's general fund of 55 million is 73% generated from revenue we rely on from the per pupil allocation from the State of South Carolina. We have not come before you, Council, for a requested increase in local revenue since 2019.

Thank you for reviewing this information. We hope soon you will consider the Colleton County School District's call for the County's full support moving forward as we improve, empower, and create the best we can for ALL of Colleton.

Finally, I look forward to our meeting to better understand the County's considerations for space intended for a charter school.

As our school district represents the largest group of school-age children in our county, we want to make sure Council knows the impact decisions will have on our district's state funding. We have the greatest influence in creating Colleton County's future and upcoming workforce! you all to know that there are not many people like Mr. Homer. He will be greatly missed by all of us, thank you.

Vice Chairman Taylor: Stated, thank you Dr. Flowers. As a child, the late Mr. Floyd Buckner used to take me down to Vacation Bible School in Islandton. He introduced me to the people of the neighborhood and would take me around, and come to find out, Mr. Homer was one of those people. When I was a little boy, around eight years old and throughout the years, it has been delightful. He used to cook those big pots of rice, and I think he and Mr. Gene Whetsell used to compete. I saw a man who would give back to the community, because he didn't have to do these things as he was retired. I went to the wake and saw the great outpouring and was told that at the celebration of life there was equally a great presence of Colletonians. All races and age groups were there to recognize and say how much they appreciated him. I didn't know him really well, but the interactions that I did have were great. We will keep Steve and the entire family in our prayers.

ORDINANCE NO. 24-O-05

COUNCIL-ADMINISTRATOR FORM OF GOVERNMENT FOR COLLETON COUNTY

[AN ORDINANCE TO ESTABLISH, PURSUANT TO SECTION 4-1-170 OF THE CODE OF LAWS OF SOUTH CAROLINA 1976, AS AMENDED, A MULTI-COUNTY BUSINESS PARK IN CONJUNCTION WITH CHARLESTON COUNTY, SOUTH CAROLINA; TO PROVIDE FOR A WRITTEN AGREEMENT WITH CHARLESTON COUNTY AS TO THE SHARING OF THE REVENUES AND EXPENSES OF THE PARK; TO PROVIDE FOR THE DISTRIBUTION OF REVENUES FROM THE PARK AMONG TAXING ENTITIES HAVING JURISDICTION OVER THE PARK; TO PROVIDE FOR A FEE IN LIEU OF AD VALOREM TAXATION; AND OTHER MATTERS RELATED THERETO.]

WHEREAS, Colleton County, South Carolina ("Colleton County") and Charleston County, South Carolina ("Charleston County") (collectively, the "Counties" and together with any additional counties that become parties to the MCP Agreement described below, the "Member Counties"), as authorized under Article VIII, Section 13(D) of the South Carolina Constitution and Section 4-1-170 of the Code of Laws of South Carolina, 1976, as amended (the "Act"), propose to establish jointly a multi-county industrial/business park within the geographical boundaries of one or more of the Member Counties (the "Park"); and

WHEREAS, Article VIII, Section 13(B) of the South Carolina Constitution provides that nothing in the State Constitution may be construed to prohibit any of the counties in South Carolina from agreeing to share the lawful cost, responsibility, and administration of functions with one or more governments; and

WHEREAS, certain real property sites which the Counties, from time to time, desire to include within the Park will be used or developed as affordable housing facilities, in whole or in part (as determined from time to time by the applicable County); and

WHEREAS, the Counties desire to establish the Park pursuant to a MCP Agreement (as defined below); and

WHEREAS, in order to promote the economic growth of Colleton County and Charleston County, the Park will be created pursuant to the terms of the "Agreement for the Establishment of Multi-County Business Park for Affordable Housing," the form of which is attached hereto as Exhibit A (the "MCP Agreement");

WHEREAS, the Counties have agreed to the specific terms and conditions of the arrangement set forth in the MCP Agreement; and

WHEREAS, the Counties now desire to establish the Park, although the Park will include no real property sites until the provisions to include real property as provided in the MCP Agreement have complied with;

NOW, THEREFORE, BE IT ORDAINED BY THE COLLETON COUNTY COUNCIL AS FOLLOWS:

Section 1. Establishment of Multi-County Park; Approval of MCP Agreement; Location of Park; Change of Park Boundaries.

- (a) There is hereby authorized to be established, initially in conjunction with Charleston County, a multi-county business park. The form, provisions, terms, and conditions of the MCP Agreement before the meeting at which this Ordinance receives third reading and filed with the Clerk to County Council be and they are hereby approved, and all of the provisions, terms, and conditions thereof are hereby incorporated herein by reference as if the MCP Agreement were set out in this Ordinance in its entirety.
- (b) The MCP Agreement is to be in substantially the form as presented at the meeting at which this Ordinance received third reading and is hereby approved, or with such changes therein as shall not materially adversely affect the rights of Colleton County thereunder and as shall be approved by the officials of Colleton County executing the same, their execution thereof to constitute conclusive evidence of their approval of any and all changes or revisions therein from the form of the MCP Agreement before the meeting at which this Ordinance received third reading. The Chairman of County Council, for and on behalf of Colleton County, is hereby authorized, empowered, and directed to do any and all things necessary or proper to effect the establishment of the Park and the execution and delivery of the MCP Agreement and the performance of all obligations of Colleton County under and pursuant to the MCP Agreement and to carry out the transactions contemplated thereby and by this Ordinance.
- (c) It is recognized that the Park will from time to time consist of contiguous and non-contiguous properties within each or any Member County. The boundaries of the Park may be enlarged or diminished from time to time as authorized by (a) an ordinance of the Member County in which the property to be added or removed from the Park is actually located, and (b) a resolution (or comparable action) of the governing bodies of the other Members.

Section 2. Payment of Fee-in-lieu of Taxes.

(a) In accordance with Article VIII, Section 13(D) of the South Carolina Constitution, the area comprising the Park and all property having a situs therein is exempt from all *ad valorem* taxation. All owners and lessees of property situated in the Park will pay a fee in lieu of *ad valorem* taxes as provided for in the MCP Agreement. The fee paid in lieu of *ad valorem* taxes shall be paid to the county treasurer of the county in which such property is located. That portion of the fee from the Park property located in a Member County and allocated pursuant to the MCP Agreement to the other Member County shall be paid to the respective county treasurer (or other designated official) of the other Member County in accordance with the terms of the

- MCP Agreement. Payments of fees in lieu of *ad valorem* taxes will be due on the due date for taxes for a particular year. Penalties for late payment will be at the same rate as late tax payments. Any late payment beyond the due date will accrue interest at the rate of statutory judgment interest. The Member Counties, acting by and through the appropriate official, shall maintain all liens and rights to foreclose upon liens provided for counties in the collection of *ad valorem* taxes.
- (b) Nothing herein shall be construed to prohibit any Member County from negotiating and collecting reduced fees in lieu of taxes pursuant to Title 4, Chapter 29 or Chapter 12, or Title 12, Chapter 44 of the Code of Laws of South Carolina 1976, as amended, or any similar provision of South Carolina law.
- **Section 3. Sharing of Expenses and Revenues.** Sharing of expenses and revenues of the Park by the Member Counties shall be as set forth in the MCP Agreement.
- **Section 4. Distribution of Revenues to Taxing Entities.** Revenues from the Park shall be distributed to and within the Member Counties as set forth in the MCP Agreement.
- Section 5. Governing Laws and Regulations. In order to avoid any conflict of laws or ordinances among the Member Counties, the ordinances or other local laws of each Member County will be the reference for such regulations or laws in connection with Park premises located within such Member County. Nothing herein shall be taken to supersede any applicable municipal, state, or federal law or regulation. The Member County in which a parcel of Park premises is located is specifically authorized to adopt restrictive covenants and land use requirements in accordance with law for each such parcel at that Member County's sole discretion. The ordinances of a Member County shall in no way apply to Park property not located in such Member County.
- **Section 6. Savings Clause.** If any portion of this Ordinance shall be held void or otherwise invalid, the validity and binding effect of the remaining portions shall not be affected thereby.
- **Section 7. General Repealer.** Any prior ordinance or resolution of Colleton County Council, the terms of which are in conflict herewith, is, only to the extent of such conflict, hereby repealed.
- **Section 8. Effectiveness.** This Ordinance shall be effective upon approval following third and final reading.
