#### COUNCIL-ADMINISTRATOR FORM OF GOVERNMENT FOR COLLETON COUNTY

[Authorizing the Acceptance of the Transfer of Authority for Conducting Municipal Elections in the Town of Smoaks and the Town of Williams to the Colleton County Voter Registration and Election Commission; to Define the Powers, Duties and Responsibilities Assumed by the Colleton County Voter Registration and Election Commission for the Conduct of Municipal Elections in the Town of Smoaks and the Town of Williams; to Provide for Reimbursement of all Costs and Expenses Incurred by the Colleton County Voter Registration and Election Commission in the Conduct of Such Municipal Elections; and to Provide for Other Matters Relating Thereto.]

#### **WHEREAS:**

- 1. As an incident to the adoption of this ordinance, the Colleton County Council as the governing body of Colleton County, South Carolina makes the following findings. Section 5-15-145 of the South Carolina Code of Laws, 1976, as amended, provides for the transfer of the powers, duties and responsibilities for conducting municipal elections from municipal election commissions to the county election commission, upon the adoption of an appropriate ordinance by the governing body of the municipality transferring such powers, duties and responsibilities and adoption of an ordinance by the county governing body of an appropriate ordinance accepting the transfer of authority for conducting municipal elections; and
- 2. The Town of Smoaks has indicated their desire to transfer all authority for conducting municipal elections within the Town of Smoaks to the Colleton County Voter Registration and Election Commission, and has commenced proceedings for the adoption of an ordinance for the transfer of the powers, duties and responsibilities for conducting municipal elections in the Town of Smoaks from the Smoaks Municipal Election Commission to the Colleton County Voter Registration and Election Commission. The Colleton County Council finds that the Colleton County Voter Registration and Election Commission is willing to assume the transfer of the powers, duties and responsibilities for conducting municipal elections in the Town of Smoaks upon the terms and conditions contained in this ordinance, and the council finds that it is proper, appropriate and in the public interest for the Colleton County Council to adopt an ordinance accepting the transfer of authority for conducting municipal elections from the Smoaks Municipal Election Commission to the Colleton County

- Voter Registration and Election Commission, on the terms and conditions herein contained; and
- 3. The Town of Williams has indicated their desire to transfer all authority for conducting municipal elections within the Town of Williams to the Colleton County Voter Registration and Election Commission, and has commenced proceedings for the adoption of an ordinance for the transfer of the powers, duties and responsibilities for conducting municipal elections in the Town of Williams from the Williams Municipal Election Commission to the Colleton County Voter Registration and Election Commission. The Colleton County Council finds that the Colleton County Voter Registration and Election Commission is willing to assume the transfer of the powers, duties and responsibilities for conducting municipal elections in the Town of Williams upon the terms and conditions contained in this ordinance, and the council finds that it is proper, appropriate and in the public interest for the Colleton County Council to adopt an ordinance accepting the transfer of authority for conducting municipal elections from the Williams Municipal Election Commission to the Colleton County Voter Registration and Election Commission, on the terms and conditions herein contained.

- 1. The Colleton County Council, as the governing body of Colleton County, South Carolina, hereby accepts authority for conducting municipal elections in the Town of Smoaks and such authority is hereby transferred from the Municipal Election Commission of the Town of Smoaks to the Voter Registration and Election Commission for Colleton County in the following particulars:
  - **a.** The Colleton County Voter Registration and Election Commission for Colleton County shall advertise municipal elections, prepare and distribute ballots and election materials, appoint managers of election for each polling place, and otherwise supervise and conduct all municipal elections within the Town of Smoaks:
  - **b.** Immediately upon the closing of the polls at any municipal election in the Town of Smoaks, the Colleton County Voter Registration and Election Commission shall begin to count and continuously count the votes cast and make a statement of the whole number of the votes cast in such election together with the number of votes cast for each candidate for mayor and councilperson, canvas the vote and publicly display the unofficial results;
  - c. The Voter Registration and Election Commission shall thereafter certify the results of the elections and transmit the certified results to the Smoaks Town Council or an appointed authority representing the town government as soon as practicable following the certification;

- **d.** Accept candidate filings and filing fees, including, but not limited to, notices of candidacy, candidacy pledges, hear and decide protests and certify the results of municipal elections;
- **e.** Utilize an Automated Election System and computer counting with the count publicly conducted;
- **f.** Take such other action as may be necessary or appropriate to conduct municipal elections and certify the results.
- 2. The Colleton County Council, as the governing body of Colleton County, South Carolina, hereby accepts authority for conducting municipal elections in the Town of Williams and such authority is hereby transferred from the Municipal Election Commission of the Town of Williams to the Voter Registration and Election Commission for Colleton County in the following particulars:
  - a. The Colleton County Voter Registration and Election Commission for Colleton County shall advertise municipal elections, prepare and distribute ballots and election materials, appoint managers of election for each polling place, and otherwise supervise and conduct all municipal elections within the Town of Williams;
  - b. Immediately upon the closing of the polls at any municipal election in the Town of Williams, the Colleton County Voter Registration and Election Commission shall begin to count and continuously count the votes cast and make a statement of the whole number of the votes cast in such election together with the number of votes cast for each candidate for mayor and councilperson, canvas the vote and publicly display the unofficial results;
  - c. The Voter Registration and Election Commission shall thereafter certify the results of the elections and transmit the certified results to the Williams Town Council or an appointed authority representing the town government as soon as practicable following the certification;
  - **d.** Accept candidate filings and filing fees, including, but not limited to, notices of candidacy, candidacy pledges, hear and decide protests and certify the results of municipal elections;
  - e. Utilize an Automated Election System and computer counting with the count publicly conducted;
  - **f.** Take such other action as may be necessary or appropriate to conduct municipal elections and certify the results.

- 3. The Town of Smoaks shall reimburse the Registration and Election Commission of Colleton County for all costs incurred in providing ballots, advertising elections, printing costs, postage, transportation costs, temporary help, programming charges, poll managers compensation and other related additional expenses incurred in its conduct of municipal elections in the Town of Smoaks. In the event a protest is filed or litigation is commenced in connection with the conduct of municipal elections, the Town of Smoaks shall pay all court costs, attorney fees, court reporter fees and costs, and other costs and expenses incurred in such protest or litigation. The Colleton County Voter Registration and Election Commission shall provide invoices and/or other documentation to the Town of Smoaks of all such costs and expenses incurred in the conduct of the Town of Smoaks municipal elections, protests, certification of results, litigation or other costs which may be incurred, not specifically mentioned in this ordinance.
- 4. The Town of Williams shall reimburse the Registration and Election Commission of Colleton County for all costs incurred in providing ballots, advertising elections, printing costs, postage, transportation costs, temporary help, programming charges, poll managers compensation and other related additional expenses incurred in its conduct of municipal elections in the Town of Williams. In the event a protest is filed or litigation is commenced in connection with the conduct of municipal elections, the Town of Williams shall pay all court costs, attorney fees, court reporter fees and costs, and other costs and expenses incurred in such protest or litigation. The Colleton County Voter Registration and Election Commission shall provide invoices and/or other documentation to the Town of Williams of all such costs and expenses incurred in the conduct of the Town of Williams municipal elections, protests, certification of results, litigation or other costs which may be incurred, not specifically mentioned in this ordinance.
- 5. This ordinance shall take effect upon the successful completion of the following necessary actions prerequisite under federal and state law to effect the changes called for hereunder:
  - **a.** Adoption of an appropriate ordinance by the governing body of the Town of Smoaks transferring the authority accepted hereunder;
  - **b.** Adoption of an appropriate ordinance by the governing body of the Town of Williams transferring the authority accepted hereunder;
  - **c.** Adoption of an appropriate ordinance by the governing body of Colleton County accepting the authority being transferred hereunder;
  - **d.** Submission to the United States Justice Department and subsequent receipt of pre-clearance and positive response to the transfer of authority for conducting municipal elections which would be effected hereunder.

#### **6.** Severability:

If any provision of this Ordinance or the application thereof to any person or circumstances is held invalid, the invalidity does not affect other provisions or applications of the Ordinance which can be given effect without the invalid provision or application and to this end, the provisions of this Ordinance are severable.

#### 7. Conflict:

Provisions in other County Ordinances, Resolutions, policies, or by-laws in conflict with this Ordinance are hereby repealed.

A front end loader garbage truck, like many pieces of heavy equipment, has a long lead time for production, but the Fleet Management department been made aware that a built unit is available for purchase from Amick Equipment out of North Carolina, due to an order cancellation. Fleet Management has reviewed the specifications of this available unit, and determined that it meets the County's specifications, and includes a drop axle, which the County had foregone in order to stay within budget; and
- 3. The purchase price of this unit is \$243,370.56 including sales tax. This price includes the North Carolina Sheriff's Association Heavy Equipment Procurement Program discount, as well as the application of the deposit made by the original buyer; and
- **4.** Section 3.08.195 of the County's Purchasing Ordinance allows the County to participate in cooperative purchasing arrangements; and
- **5.** Funding for this purchase is available within the 2018-2019 Lease Purchase.

- 1. The purchase of a Peterbuilt Front End Loader Garbage Truck from Amick Equipment in the amount of \$243,370.56 in accordance with Section 3.08.195 of the County's Purchasing Code is hereby approved.
