Council Chambers 109 Benson Street, 2<sup>nd</sup> Floor Walterboro, SC 29488 Colleton County, South Carolina (the **"County"**) is requesting bids from qualified vendors for removal and recycling of scrap tires at the Solid Waste Complex located at 3288 Green Pond Highway, Walterboro, South Carolina, 29488.

Subject to the terms, conditions, provisions, and the enclosed specifications, responses to this solicitation will be received at this office until the stated date and time. Responses received after the scheduled due date and time will be rejected. Bids must be submitted in a sealed package marked on the outside with the Offerors name, address, and the solicitation name and number.

This solicitation does not commit Colleton County to award a contract, to pay any costs incurred in the preparation of bids submitted, or to procure or contract for the services. The County reserves the right to accept or reject or cancel in part, or in its entirety offers received as a result of this request if deemed to be in the best interest of the County to do so.

Answers to all questions will be posted on the County website at www.colletoncounty.org as addendums to this invitation for bid. It is the responsibility of the Vendor to check the website for addenda up to the time of the bid opening.

#### INSTRUCTIONS TO BIDDERS

1. Submittal must include **one (1) original bid** clearly marked as original, and **two (2) complete copies** of the Offeror's bid along with a **completed W-9 form**. Responses must be in a sealed envelope/package containing the solicitation name and number.

The individual signing the response must be an Agent legally authorized to bind the company.

- 2. Show solicitation number on the outside of mailing package. Colleton County assumes <u>no</u> responsibility for unmarked or improperly marked envelopes
- 3. It is the Offeror's sole responsibility to insure that solicitation responses, amendments thereto or withdrawal requests are submitted by the scheduled due date and time.
- 4. Offeror must clearly mark as "Confidential" each part of their response, which they consider to be proprietary information that could be exempt from disclosure under Section 30-40(C) Code of Laws of South Carolina, 1976, Freedom of Information Act. Colleton County reserves the right to determine whether this information should be exempt from

disclosure and legal action may not be brought against the County or its agents for its determination in this regard.

5. RESPONSE FORM: All responses shall be printed in ink or typewritten. If required, additional pages may be attached. Bids written in pencil will be disqualified.

A "No Response" qualifies as a response; however it is the responsibility of the Offeror to notify the Procurement Office if you receive solicitations that do not apply.

#### SPECIFIC TERMS AND CONDITIONS

- 1. **COMPETITION**: This solicitation is intended to promote full and open competition. If any language, specifications, terms and conditions, or any combination thereof restricts or limits the requirements in this solicitation to a single source, it shall be the responsibility of the interested vendor to notify the Procurement Office in writing no later than five (5) business days prior to the scheduled due date and time.
- **2. BIDDERS QUALIFICATION**: The County reserves the right to request satisfactory evidence of their ability to furnish services in accordance with the terms and conditions listed herein. The County further reserves the right to make the final determination as to the Offerors ability to provide said services.
- **3. BID WITHDRAWAL**: Any responses may be withdrawn prior to the established closing date and time, but not thereafter with proper approval from the Procurement Director.
- **4. REJECTION**: Colleton County reserves the right to reject any and all bids, to cancel or withdraw this solicitation, and to waive any technicality if deemed to be in the best interest of the County.
- **5**. **WAIVER**: The County reserves the right to waive any Instruction to Offerors, General or Special Provisions, General or Special Conditions, or specifications deviation if deemed to be in the best interest of the County.
- **6**. **RESPONSE PERIOD**: All responses shall be good for a minimum period of 60 calendar days.
- 7. **DEVIATIONS FROM SPECIFICATIONS**: Any deviation from specifications indicated herein must be clearly pointed out; otherwise, it will be considered that items offered are in strict compliance with these specifications, and successful bidder will be held responsible therefore. Deviations must be explained in detail on separate attached sheet(s). The listing of deviations, if any, is required but will not be construed as waiving

any requirements of the specifications. Unidentified deviations found during the evaluation of the response <u>may be cause for rejection</u>.

- **8**. **AMENDMENTS**: All amendments to and interpretations of this solicitation shall be in writing and issued by the Procurement Manager of Colleton County.
- **9. DEFAULT**: In case of default by the Offeror, the County reserves the right to purchase any or all items in default in the open market, charging the Offeror with any excessive costs. Should such charge be assessed, no subsequent solicitation response of the defaulting Offeror will be considered in future bids until the assessed charge has been satisfied.
- 10. NON-APPROPRIATION / SUBSTITUTION PERMITTED: If the Colleton County Council fails to appropriate or authorize the expenditure of sufficient funds to provide the continuation of this contract or if a lawful order issued in, or for any fiscal year during the term of the agreement, reduces the funds appropriated or authorized in such amounts as to preclude making the payments set out therein, the agreement shall terminate on the date said funds are no longer available without any termination charges or other liability incurring to County. Following any such non-appropriation, the master lease agreement shall contain no limitation on the County's ability to replace the equipment financed with any other equipment.
- 11. **INDEMNIFICATION**: Except for expenses or liabilities arising from the negligence of the County, the Offeror hereby expressly agrees to indemnify and hold the County harmless against any and all expenses and liabilities arising out of the performance or default of any resulting agreement or arising from or related to the Work as follows: Offeror expressly agrees to the extent that there is a causal relationship between its negligence, action or inaction, or the negligence, action or inaction of any of its employees or any person, firm, or corporation directly or indirectly employed by the Offeror, and any damage, liability, injury, loss or expense (whether in connection with bodily injury or death or property damage or loss) that is suffered by the County and its employees or by any member of the public, to indemnify and save the County and its employees harmless against any and all liabilities, penalties, demands, claims, lawsuits, losses, damages, costs, and expenses arising out of the performance or default of any resulting agreement or arising from or related to the equipment. Such costs are to include defense, settlement and reasonable attorneys' fees incurred by the County and its employees. This promise to indemnify shall include bodily injuries or death occurring to Offeror's employees and any person, directly or indirectly employed by Offeror (including without limitation any employee of any subcontractor), the County's employees, the employees of any other independent contractor, or occurring to any member of the public. When the County submits notice, Offeror shall promptly defend any aforementioned action. The prescribed limits of insurance set forth herein shall not limit the extent of the Offeror's responsibility under this Section. The terms and conditions contained in this Section shall

survive the termination of any resulting agreement or the suspension of the Work hereunder. Additionally the County will not provide indemnity to the successful bidder. Failure to comply with this section may result in your bid to be deemed non-responsive.

- 12. FORCE MAJEURE: The Offeror shall not be liable for any excess costs if the failure to perform the resulting agreement arises out of causes beyond the control and without fault or negligence of the Offeror. Such causes may include, but are not restricted to acts of God or of the public enemy, acts of the Government in either its sovereign or contractual capacity, fires, floods, epidemics, quarantine restrictions, strikes, freight embargoes, and unusually severe weather; but in every case the failure to perform must be beyond the control and without the fault or negligence of the contractor. If the failure to perform is caused by default of a subcontractor, and if such default arises out of causes beyond the control of both the Offeror and subcontractor and without excess costs for failure to perform, unless the supplies or services to be furnished by the subcontractor were obtainable from other sources in sufficient time to permit the contractor to meet the required delivery schedule.
- **13**. **ARBITRATION**: Under no circumstances and with no exception will Colleton County act as arbitrator between the Offeror and any sub-contractor.
- 14. PUBLICITY RELEASES: Offeror agrees not to refer to award of this contract in commercial advertising in such a manner as to state or imply that the products or services provided are endorsed or preferred by the County. The Offeror shall not have the right to include the County's name in its published list of customers without prior approval of the County Administrator. With regard to news releases, only the name of the County, type and duration of any resulting agreement may be used and then only with prior approval of the County. The Offeror also agrees not to publish, or cite in any form, any comments or quotes from the County's staff unless it is a direct quote from the Procurement Director.
- **15**. **GOVERNING LAWS**: Any agreement arising from this solicitation shall be governed by the laws of the State of South Carolina and any and all disputes arising out of said agreement shall, if litigation is necessary, be litigated only in a Circuit Court for the Fourteenth Judicial Circuit sitting in Colleton County, South Carolina. The prevailing party shall be entitled to attorney's fees and all costs of said litigation.
- **16**. **ASSIGNMENT**: The Offeror shall not assign in whole or in part any agreement resulting from this Request for Bids without the prior written consent of the County. The Offeror shall not assign any money due or to become due to him under said agreement without the prior written consent of the County.
- **17**. **AFFIRMATIVE ACTION**: The successful Offeror will take affirmative action in complying with all Federal and State requirements concerning fair employment and

treatment of all employees, without regard or discrimination by reason of race, color, religion, sex, national origin or physical handicap.

#### 18. CONTRACT AWARD:

**A**. This solicitation and submitted documents, when properly accepted by Colleton County shall constitute an agreement equally binding between the successful Offeror and the County.

No oral statement of any person shall modify or otherwise change, or affect the terms, conditions or specifications stated in the resulting agreement. The County shall not be legally bound by any amendment or interpretation that is not fully executed by both parties in writing.

- **B.** The successful Offeror shall be required to execute a formal agreement with the County's Procurement Office <u>within ten (10) business days after issuance of the Notice of Award</u>.
- **19. PURCHASING CARD**: By submitting a bid, contractor agrees to accept payment by the Colleton County Purchasing Card for no extra charge. The Purchasing Card is issued by Visa. The purchasing card allows county agencies to make authorized purchases from a vendor, in conjunction with a purchase order.
- **20. INSURANCE:** Colleton County will require the following remain in force at all times through the life of the contract:

## MINIMUM SPECIFICATIONS FOR REMOVAL AND RECYCLING OF SCRAP TIRES AT SOLID WASTE COMPLEX

Colleton County is requesting bids from qualified vendors to establish a term contract for removal and recycling of scrap tires at the Solid Waste Complex, 3288 Green Pond Highway, Walterboro, South Carolina.

#### **Scope of Work**

Contractor shall provide all equipment necessary to collect, transport, and process waste tires from the Colleton County Solid Waste Complex, 3288 Green Pond Highway, Walterboro, SC 29488 on an "as needed" basis. Colleton County will have approximately 24 loads of tires per year.

Contractor's facility shall be duly permitted by SCDHEC to recycle and dispose of tires. Contractor shall provide appropriate documentation with bid proposal. All tires removed must be delivered to a SCDHEC permitted recycling processor.

Contractor will enter the land fill accessing the weight scale, after trailer is loaded, contractor will exit stopping on scale to received proper paper work from scale of tons loaded. Hour of operation Monday – Friday 8:00am -4:30pm.

Colleton County will stockpile tires in a 43L x 34Wx 14H tire bin. When bin is at full capacity the county will contact the contractor. The contactor shall pick up the tires within forty-eight 48 hours of initial notification, using their own equipment and employees. If the company does not respond within the allotted 48 hours, one hundred and fifty dollars (\$150.00) per day will be charged to the contractor.

Tires shall be properly removed and recycled in accordance with all State and Federal laws governing scrap tires.

#### **Pricing**

Contractor shall quote a price per ton, which shall include transportation, recycling, and/or disposal cost. If the contractor charges any type of surcharge fees (i.e., fuel charges, minimum tonnage requirement, or a certain number of tires per load on rims, tire size, off-

road equipment, excessively dirty, etc.), please state your charge and condition on the Bid Form.

#### **Payment**

All tires removed must be delivered to a SCDHEC permitted recycling processor. As a condition precedent to payment, the Contractor must furnish DHEC manifested proof of end facility in order for the County to receive recycling credits.

#### **Contract Term**

The initial contact service dates shall be from July 15, 2014 to June 30, 2015. Renewal periods thereafter shall be from July 1<sup>st</sup> to June 30<sup>th</sup>.

#### References

Please include three (3) references where you have performed similar services. The references should include company name, contact person and phone number.

The Contractor must be a registered tire hauler in good standing with SCDHEC.
 The processor must be a permitted SCDHEC tire processor. Proof of registration and permitting must be submitted with bid.
 The County reserves the right to review SCDHEC public records to ascertain compliance with all site and operational regulations, and to reject bids where failure to comply is documented.

#### GENERAL CONDITIONS

- A) Abandonment or Delay: If the work to be done under this contract shall be abandoned or delayed by the Offeror, or if at any time the County shall be of the opinion and shall so certify in writing that work has been abandoned or delayed by the Offeror, the County may annul the contract or any part thereof if the Offeror fails to resolve the matter within thirty (30) days of written notice.
- **B)** Offeror's Cooperation: The Offeror shall maintain regular communications with the Solid Waste Director and shall actively cooperate in all matters pertaining to this contract.
- **C) Responsibility:** The Offeror shall at all times observe and comply with all federal, state, local and municipal laws, ordinances, rules and regulations in any manner affecting the contract.
- **D)** Hold Harmless: All respondents to this bid shall indemnify and hold harmless Colleton County Government and any of their officers and employees from all suits and claims alleged to be a result of this bid. The issuance of this bid constitutes only an invitation to present a proposal. Colleton County reserves the right to determine, at its sole discretion, whether any aspect of a respondent's submittal meets the criteria in this bid. Colleton County also reserves the right to seek clarifications, to negotiate with any vendor

submitting a response, to reject any or all responses with or without cause, and to modify the procurement process and schedule.

In the event that this bid is withdrawn or the project canceled for any reason, Colleton County shall have no liability to any respondent for any costs or expenses incurred in connection with this bid or otherwise.

- **E)** Colleton County Procurement Policy: The Bid is subject to the provisions of the Colleton County Procurement Ordinance and any revisions thereto, which are hereby incorporated into this bid in their entirety except as amended or superseded within.
- **F)** Failure to Submit All Mandatory Forms: Failure to submit all the mandatory forms from this Bid package shall be just cause for the rejection of the qualification package. However, Colleton County reserves the right to decide, on a case by case basis, in its sole discretion, whether or not to reject such a bid as non-responsive.
- **G)** Failure to Deliver Goods in Accordance with Terms & Conditions: In case of failure to deliver goods in accordance with the contract terms and conditions, Colleton County, after due oral or written notice, may procure substitute goods or services from other sources and hold the contractor responsible for any resulting additional purchasing and administrative costs. This remedy shall be in addition to any other remedies which Colleton County may have.
- **H) Debarment:** By submitting a qualification package, the vendor is certifying that they are not currently debarred from bidding on any contracts by any agency or subdivision of the State of South Carolina, nor are they an agent of any person or entity that is currently debarred from submitting bids on contracts by any agency or subdivision of the State of South Carolina.

#### I) Termination of Contract

- 1. Subject to the Provisions below, the contract may be terminated by the Purchasing Department providing a thirty (30) days advance notice in writing is given to the offeror.
- a. Termination for Convenience: In the event that this contract is terminated or canceled upon request and for the convenience of the County without the required thirty (30) days advance written notice, then the County shall negotiate reasonable termination costs, if applicable.
- b. Termination for Cause: Termination by the County for cause, default or negligence on the part of the offeror shall be excluded from the foregoing provisions; termination costs, if any, shall not apply. The thirty (30) days advance notice requirement is waived and the default provision in this bid shall apply.

- c. The County shall be obligated to reimburse the Offeror only for those services rendered prior to the date of notice of termination, less any liquidation damages that may be assessed for non-performance.
- 2. Non-Appropriations Clause: Not withstanding any other provisions of the contract, if the funds anticipated for the continued fulfillment of this contract are at any time

Not forthcoming, through the failure of the County Government to appropriate funds, discontinuance or material alteration of the program under which funds were provided, the County shall have the right to terminate the contract without penalty by giving not less than thirty (30) days written notice documenting the lack of funding.

Unless otherwise agreed to by the County and the Offeror, the contract shall become null and void on the last day of the fiscal year for which appropriations were received.

- J) Governing Laws: Any contract resulting from this bid shall be governed in all respects by the laws of the State of South Carolina and any litigation with respect thereto shall be brought in the courts of the State of South Carolina.
  - **K)** Bonds: Payment and Performance Bonds are not required for this bid.
