Addendum #3 dated 9-25-2018

The following questions have been submitted for clarification:

- 1) Will a Bid Bond be required? Answer: Yes, a bid bond for 5% of the bid price is required. This can be in the form of a surety bond or certified check.
- 2) Are Performance and Payment Bonds required? Answer: The requirement for the 100% of contract price Performance and Payment Bond is hereby removed.
- 3) Is there a spec for the Borrow Material line item? Answer: Borrow material shall be a sand clay material similar to the current fill material observed during the site visit. Borrow material is not top soil.
- 4) Is there a spec for the Graded Aggregate Base Course? Answer: This line item shall be a well graded aggregate per SCDOT spec. (i.e. FLBC-limestone or MBC-granite)
- 5) Is there a spec for the Rip-Rap? Answer: Class B.
- 6) Are compaction tests required on the slopes after fill is placed? Answer: No.
- 7) Where is the sodding to be placed? Answer: This is to be placed at the inlet to the slope drains.
- 8) Is the HDPE to be single wall or double wall? Answer: Single wall.
- 9) Is there a spec for the 15" HDPE Grate Inlet? Answer: This item is hereby removed from the bid. See new bid tab.
