Call to Order: Chairman Scott Biering called the meeting to order at 5:30 p.m.

Roll Call: Chairman Scott Biering, Council Vice-Chairman Bubba Trippe, Councilman Steve Murdaugh, Councilman Johnny Frank, and Councilman Phillip Taylor were present.

Invocation & Pledge of Allegiance: Councilman Taylor gave the invocation and led the Pledge of Allegiance.

Approval of Agenda: Councilman Taylor made a motion to approve the agenda, seconded by Councilman Trippe. The motion carried unanimously.
