Approval of Minutes

Awards and Recognition's

SCAPA Award- Colleton Museum & Farmers Market

Mr. Phillip Slayter, member of the SCAPA- at the annual Fall Conference in October of this year Colleton County received the 2012 Chapter Award for Outstanding Planning Project for the Museum/Farmers Market. They chose the Museum/Farmers Market for its use of a collaborative planning process as well as the building's design and re-use as a signature example of how the county may preserve and advance its social, cultural, and economic heritage. On behalf of the chapter he presented the award to Mrs. Gary Brightwell, Director of the Museum/Farmers Market.

Administrative Briefing

Mr. Griffin said our January council meeting falls on January 1st; the chairman had asked me to check into an alternate date. That date will be January 8th, which will be the following Tuesday, so we will be moving the 1st meeting of the month to January 8th.

The Department Head Christmas Luncheon, we would like to inform council that will be December 18th at the Quick Job Center out in the Industrial Park across from Station 19 and it will start at 12 noon.

We applied a while back for a CDBG grant roughly \$250,000 to demo the old, old jail beside the current jail; that property and the Breland Building. As you know both of

them have lead paint, asbestos, and some other environmental issues. We had looked at demoing them ourselves, but it was a very high cost. We were able to make application and received CBDG awarded that grant this week so we will be starting that project the 1st of the year as well.

The Recreational Park itself is all but finished. We are going through a punch list now. We do have a small change order before you tonight regarding addition, which we spoke to council I believe last meeting about the additional parking spaces. The current electrical system on the tennis courts was dated. We were able to remove that meter and join it to the new picnic shed meter, but it did require a little additional re-wiring and some things of that nature, which will be a part of that change order later on the agenda, which will both be adds to the contract. They have already poured the 1st basket ball court, today they were working on the 2nd one this morning when I was out there early this morning, so that is coming along well and hopefully we will be planning a ribbon cutting sometime the 1st of the year on that project.

Mr. Robinson said as a point of clarification is that the grant we received \$285,000?

Mr. Griffin said we got another it was a tire grant from DHEC for a project we were working. We had a major tire issue in the county and that one has been going on like 4-5 years now, but we did get a grant from DHEC.

Mr. Robinson said so we are talking about two grants.

Mr. Griffin said that was a separate grant about \$235,000, which we have that out for bid now as well.
