Mr. Griffin said a few items on the agenda are primarily grant related. We applied about 2 ½ years ago when we started the Hampton Street Auditorium Project and were notified in December that we had been award two \$50,000 grants for two separate pieces of the

Hampton Street Auditorium Construction from USDA and am very glad to hear that. Those grants are being appropriated in this budget as well as Heyward has been working with Pioneer Boats on an expansion there. We have coordinated with SC Dept. of Commerce and they have been awarded a \$100,000.00 Economic Development Grant for expansion and new jobs there for some of the improvements to their facility. Very happy to hear that they continue to expand and add jobs and doing a great job in our community as well.

Mr. Griffin said Coastal Electric as they have been doing for a number of years now. Their RDA Funds of \$131,000 they have again elected to give that to our county Economic Development efforts primarily related to the park at exit 62.
