#### **Council Time**

Mr. Taylor said I know we did the authorization for the Youth Offender Entry Program. Ms. Slater is here and didn't know if she wanted to give us any updates of what's going on with the project.

Ms. Slater said right now I appreciate you letting the Department of Correction use your building out there. We have now been out there six years and since that time the ...inaudible... rate for a youth offender has dropped significantly in this county as well as the other counties. Again, I would like to thank you for the use of your building.

Mr. Whetsell said during this week I met with Ms. Graham from LCOG in reference to maybe doing something with the Community Center up in Springtown and there is some money in that area we will be talking to the Administrator about that in the near future.

Mr. Robinson said Mr. Administrator the project that was going on, on Lemack Street, I think we pursued also some help from LCOG and I understand that they had reneged on those requests based on the Neyles Community not having the numbers, population for the Grant. Are you familiar with that?

Mr. Griffin said the Lemacks Street project?

Mr. Robinson said the Neyles project, so you are familiar with that project?

Mr. Griffin said yes sir, very familiar with that project.

Mr. Robinson said do we have any other resources or recourse we can take?

Mr. Griffin said we are actually going to re-apply. They told us what the issues were last time and we've got an idea to re-work that, but that grant funding cycle for those projects is in August. They only do public infrastructure in the Spring which is water, sewer and roads.

Mr. Robinson said I am going back to the Lemacks Street project, the infrastructure and stuff they have put in. Is that completed now?

Mr. Griffin said that is a City project. We assisted the City. We sponsored the application because you only have a number of application spots you get for CDBG and they were full, so we sponsored their application for them.

Mr. Robinson said Councilman Whetsell and Councilman Flowers and myself don't like for Colleton County to be left out of anything.

Mr. Taylor said I thought I saw Mr. Phillip Slaytor here, he must have left, but for the next three weeks he is going to be stationed at Saints Center Ministries in Walterboro helping people fill out the applications for the funds that came through the revitalization project along Gadsden Loop so there are resources available for people. Those people or persons living from Robertson Blvd. at that corner of Robertson and Hampton going back up to Rivers and around to Gadsden Loop and all the way back around Purifoy Road coming back up to Hampton, those people that live in that little sandwiched area have an opportunity to apply. They have certain stipulations and they will be there to help people fill those applications out. So there are things that they will need

Mr. Griffin interrupted said they have all been notified individually as well.

Mr. Taylor said some notices went out by mail, some people have been knocking on doors, but people need to know he will be there from 4:00-6:00 for the next three Wednesdays including tomorrow.
