Colleton County Council met in Regular Session on Tuesday, September 11, 2018 at 6:00 PM, at the County Council Chambers, Old Jail Building. Dr. Flowers called the meeting to order with Council Members Steven Murdaugh, Gene Whetsell, Evon Robinson (Late), Phillip Taylor in attendance.

Mr. Taylor seconded the motion.

Dr. Flowers said that is an emergency type thing and appropriate to amend the agenda at this time.

Administrator's Briefing

Mr. Griffin said the County remains at OPCOM 1 primarily because Edisto is still under evacuation order. Things were looking pretty promising this morning but the models that came in at 2:00PM and 5:00PM this afternoon have the storm shifting significantly southward from the original track. Actually coming is somewhere between Georgetown and Myrtle Beach and then shifting down the coast line before it actually comes inland. After speaking with State EMD and our local officials and all of our state government offices, we have about 33 people in the shelter right now. School District's offices will be closed the rest of the week. With all the resources we need for emergency management and other things that we need to be available tomorrow to stay on top or this, we are recommending that we continue to be closed tomorrow and then we will make another decision on that after our 9:00AM meeting and the additional information we get from the state EMD at that point.

Dr. Flowers said do we need to any action on this.

Mr. Griffin said no we don't need to take any action on that at this time, we need to get the word out as soon as this is over for Court Administration and a couple of other items to make sure that they know they will not be activated tomorrow and we have gone ahead activated and spoken with our Assessor and assessment team as well to start getting them moved and those resources as well.

Mr. Murdaugh said I know the Governor has removed us from the evacuation list, us and Jasper, but there have been changes in the model.

Mr. Griffin said we all got alerts this afternoon that we needed to evacuate, so they are in a little bit of a state of flux right now. They depend on four models. Two of the four models show it impacting, the European model shows it coming in basically between Edisto and Beaufort. The FBW model I believe shows it just above Edisto coming in and the other two are somewhere between Georgetown and Myrtle Beach. All of them show in coming in and stalling out over the whole state, so we will see some significant rainfall. Possible flooding and we know that the Edisto River is always an issue when we get that type of rainfall. They are talking anywhere from 8-15" possibly. We know what the impacts are because we have dealt with them before. Beaufort County is closed, government offices everything is closed there. Everything in Dorchester County is closed, Jasper right now is operating delay in the morning, last time I spoke with Adm. Fulghum, but they had not made a final decision. They were like us waiting on this call today.
