# **Administrative Briefing**

Mr. Griffin said we have had some complications with the stairwell at the old jail building and working through some plans with the architects to get that upgraded.

Mr. Griffin said you have a resolution on the agenda tonight for the demolition at Hendersonville School. I did tell you we were bidding that one along with the Old Jail and Breland Building project at the same time. The Breland Building and the Old Jail project have to be approved by Commerce before we put it on the agenda, but will likely be on the agenda for the October meeting.

Mr. Griffin said Heyward wanted him to pass along to you. First of all Carlyle & Associates delivered to his office today the RFP and bid documents for the new spec building. We hope to get that RFP out shortly.

Mr. Griffin said Crescent Dairy & Beverage has begun construction and are moving along very well. We also have the RFQ's in for the work to be done at the Colleton Venture Park. That item will also be on the October agenda.

Mr. Griffin said we have been working very diligently on the Palmetto 800 Radio System. The lease purchase we have gotten finalized and got a great rate of 2.3% on that lease purchase.

Mr. Griffin said Jared had given him a good update on the Roads & Bridges situation. You will also see on the agenda tonight regarding Roads & Bridges. We have already approached our fund balance for the year for rock and crush & run for the roads. We do have a fund balance appropriation out of the Roads & Bridges fund balance of \$50,000 to catch that up and hopefully, if we don't get too much more of this will be able to stretch that out through the year, but may have to come back. Along with the water we have had mosquito issues. We have burned through all of our mosquito chemicals as well. We have an appropriation of what we think will take us through the rest of the fall and then the spring months when it starts to warm up.
