SCDHEC OPENS VACCINATIONS TO GROUP 1B

DATE: March 11, 2021

SCDHEC announced on Monday that with the increased supply of vaccine and progress in vaccinating people in group 1a (front line health care workers and those age 65 and over), South Carolina is ready to move on to the next phase. This plan prioritizes those with greatest risk, while ensuring equitable access to the vaccine for every South Carolinian age 16 and over.

This approach continues to recognize that risk of hospitalization and death from COVID worsens with age, especially for those over 45, and that people with certain medical conditions and occupational exposures are at higher risk. As a result, SCDHEC will move to phase 1b as described below.

Individuals in Phase 1b can make appointments beginning March 8, 2021. Phase 1b includes individuals aged 55 and older, individuals with increased risk for severe COVID-19 disease, frontline workers with increased occupational risk, individuals at increased risk in settings where people are living and working in close contact and all workers in health care and community health settings who have routine, direct patient contact and were not vaccinated in phase 1a.

The Colleton Health Department will offer first dose vaccination clinics on March 12th, 2021. There will be a corresponding second dose clinic 28 days following each first dose clinic. The link above can be used to register.

They will register you in VAMS (which requires an email address) and then VAMS will email you a registration link that you can use to register for the Walterboro Family Care vaccination site (or any other vaccination sites statewide).

"The CDC interim guidance, issued this past Monday, defines fully vaccinated people as those that are more than two weeks from their second shot of a two-shot series or two weeks from their single shot in a single shot dose. The CDC now allows for fully vaccinated people to visit with other fully vaccinated people without wearing masks or physical distancing, visit with unvaccinated people from a single household who are at low-risk for severe COVID-19 disease indoors without wearing masks or physical distancing, and refrain from quarantine and testing following a known exposure if asymptomatic," said Fire-Rescue Deputy Chief David Greene. "Fully vaccinated people should continue to wear a mask in public, take all prevention measures when visiting with unvaccinated people who are at increased risk for severe COVID-19 disease, and avoid medium- and large-sized gatherings. Fully vaccinated people should continue to wear masks, maintain physical distance, and practice other prevention measures when visiting with unvaccinated people from multiple households. Everyone should continue to get tested, regardless of vaccination status, if you are experiencing COVID-19 symptoms," Greene added.
