SCDHEC OPENS VACCINATIONS TO GROUP 1B

SCDHEC announced on Monday that with the increased supply of vaccine and progress in vaccinating people in group 1a (front line health care workers and those age 65 and over), South Carolina is ready to move on to the next phase. This plan prioritizes those with greatest risk, while ensuring equitable access to the vaccine for every South Carolinian age 16 and over.

This approach continues to recognize that risk of hospitalization and death from COVID worsens with age, especially for those over 45, and that people with certain medical conditions and occupational exposures are at higher risk. As a result, SCDHEC will move to phase 1b as described below.

Individuals in Phase 1b can make appointments beginning March 8, 2021. Phase 1b includes individuals aged 55 and older, individuals with increased risk for severe COVID-19 disease, frontline workers with increased occupational risk, individuals at increased risk in settings where people are living and working in close contact and all workers in health care and community health settings who have routine, direct patient contact and were not vaccinated in phase 1a.

The Colleton Health Department will offer first dose vaccination clinics on March 5th, 8th and 12th, 2021. There will be a corresponding second dose clinic 28 days following each first dose clinic. The link above can be used to register.

They will register you in VAMS (which requires an email address) and then VAMS will email you a registration link that you can use to register for the Walterboro Family Care vaccination site (or any other vaccination sites statewide).

"With the lifting of restrictions on bars, restaurants, and gatherings this week as well as the transition to Phase 1b next week, it is important to remember that our fight against COVID-19 is not over. Public health officials at SC DHEC continue to encourage citizens to wear face coverings, practice 'social distancing,' and avoid crowds, even after you have received the vaccine," said Fire-Rescue Chief Barry McRoy. "Until enough of us get vaccinated, we must continue these protective measures and get tested for COVID-19 to help reduce the spread of the disease and identify the presence of variants as early as possible," Chief McRoy added.
